Summer Day Camp:

- Pelissier is continue to follow all guidelines issued by the CDC, state and local officials, including Governor Sununu and our Superintendent.
- The Governor has stated some guidelines regarding day care centers but we are still awaiting guidelines specific to summer day camp
- There are currently 26 campers registered
- Children of essential workers account for more than half of registered campers
- Pelissier stated she will continue the communication with the Commission as she learns more
- The Commission agreed that a decision to continue or cancel summer day camp could not be made at this time as more information and guidance was needed to make a formal decision.

Other Business:

- Olmstead stated that he has noticed a lot of discussion on social media regarding the town beaches. There appears to be a disagreement on whether the town beach is owned by the town or state. He stated that the BOS is actively looking in to town and state records for discrepancies, as well as reaching out to appropriate contacts to help resolve this dispute
- Pelissier discussed the gate replacement at the town park. A quote was received for approximately \$2,000 to make this repair. A more cost-effective alternative is being researched. The final cost will be reimbursed by the individual that caused the damage.
