## **Town Park Sub-Committee/Ice Rink:**

Whetstone spoke about how the Committee is just an advisory committee and they can give ideas to the Commission for approval and then the selectman for final approval. They have been discussing planting at the town park and the berm between the entrance to the town park and transfer station.

Pelissier gave an ice rink update. Chief Dexter and the Sanbornton FD has been working with her to fill the rink. The initial fill had a significant leak and then we had some uncooperative weather which did not help. Chief was able to put a little over 2000 gallons in with the hopes that the snow would absorb the water and freeze quickly with the current temps reaching in the negatives. He will continue to check on it this week. Total amount spent for the rink was \$865.26 and a big thank you to Justine Barriault for taking the time out of his busy schedule to construct the rink for the community.
