  every three weeks or so. As of now, no outside organizations are allowed in the school. BSP and ASP will likely
  be the first programs allowed.
- Elliott noted that the state licensing department has been informed that we will not be operating until at least October.
- Whetstone asked how the staff is filling their time with the town's furlough officially ended. Pelissier stated that the staff is preparing the school for when we are allowed to operate once again, participating in required trainings for licensing, cleaning beaches, helping at the town park and during sports.
- Whetstone asked about the process of hiring. Pelissier stated that candidate resumes are presented to the Commission and then the BOS.

#### **Revolving Fund:**

Pelissier requested \$500 for Halloween supplies. A motion was made by Seavey to approve and seconded by Smith.

### **Town Park:**
