**Before & After Care:**

There is a waitlist for the afternoons. Elliott & Pelissier are working on updating the EOP (Emergency Operations Procedure) for the program to submit to Child Care Licensing.

**Soccer:**

Coaches have been a struggle this season. Pelissier mentioned that an incentive going forward would be to have coaches' kids free. The commission agreed. There was a total of 101 players signed up this soccer season. Due to inventory issues with suppliers, some of the teams have two different shades of orange and green. Team photos are tomorrow at the Town Park.

**Halloween:**

Costume Party at SCS is on Saturday, October 22 2:00-4:00pm. Pelissier will reach out to student council at the middle and high school to see if they can help with set up and running the games.

**Pickleball/Volleyball:**

Both programs have resumed. Pickleball with 8 registered and Volleyball with 14.

**Youth Volleyball Clinics:**

Pelissier was in touch with Joan over at Plymouth State University and she has offered to have some of her players help run the volleyball clinics. These will be held at the middle school, Pelissier will reach out about gym usage to the AD. The clinics will be set to run during Christmas Break and February Break, if the gym is not being used by any other programs. I'm thinking 5 day clinics from 10-12pm with practice, drills and scrimmages open to middle and high school players. Pelissier will have a flyer and more details at the next meeting.
